UNIVERSITY CIRCULAR

Notification of University Grants Commission dated 18-07-2018 and Government Resolution No. MISC-2018 / CR. 56/18 / UNI-1 dated March 08, 2019 and May 10, 2019 Annual Self-Appraisal Report (ASAR) has been prepared and approved by the University Board of Trustees. The following guidelines have been prepared for filling up the form and availing the benefit of promotion under Career Advancement Scheme (CAS). It should be strictly followed.

- 1. There will be two committees (Screening -cum -Evaluation and Selection Committee) to take advantage of the CAS Assured Progress Scheme.
 - a. Issue No. 6 in Government Resolution March 8, 2019 for AL-1.1, AL-12. Screening cum -Evaluation and selection committee will be constituted as per 6.1 (VIII).
 - b. Issue No. 6 in Government Resolution March 8, 2019 for promotion to the post of AL-13A, AL-14, AL 15 a selection committee will be constituted as per 6.1
- 2. Screening -cum -Evaluation committee should evaluate the following matters.
 - a. Table-I of Appendix II of Assistant Professor
 - b. Librarian Appendix II Table-4
 - c. Table 5 of the Director of Physical Education in Appendix II

Promotion under CAS should be implemented in three stages.

- a) At the end of academic year 1 to 5 in ASAR-Appendix II, the university / college should submit the appropriate documents (evidence) through HOD or Teacher in Charge. ASAR should be screened through HOD / Teacher in Charge.
- b) The teacher should submit the application through the principal after completion of the prescribed period of service for promotion. In addition, it will be implemented as per Government Resolution dated 08-07-2019.
- c) Approval of promotion by CAS GR dated 08-07-2019 issue no. 7. 4 will be done.
- iv) Evaluation criteria and methods
- a) To avail the benefit of CAS promotion, Assistant Professors, Associate Professors, Professors and Senior Professors should fill up Table 1 and Table 2 in Appendix II as per requirement and submit it to the University / College.
- b) College Librarian and Assistant Librarian / Sub-Librarian of the University should fill up Table 4 in Appendix II and submit it to the University / College to avail the benefit of CAS Promotion.
- c) The Director of Physical Education in colleges and universities should fill up Table 5 of Appendix II and submit it to the university / college to avail the benefit of CAS promotion.
- v) As per the instructions of seventh Pay Commission, the benefit of CAS promotion will be applicable as per Government Resolution dated 08-03-2019. However, teachers who have been eligible in the past or will be eligible in the near future will face CAS as per the old API until 08-03-2022 as per the 4th Amendment dated June 30, 2010 of the 6th Pay Commission. For this, they should use the API GR dated 08-03-2019 in Appendix III as per the requirements of Table-A, B, C, D, E.

- A) Written application should be made to the college / university three months before the date on which the teachers are eligible for CAS. The university administration will complete the CAS process within six months of the submission of the written application of the teacher.
- B) University administration will organize CAS camps at least twice a year through circulars.
- c) Eligible teachers who meet the minimum eligibility for promotion under CAS (AL-11, AL-12) will be eligible for CAS Promotion from due date.
- d) Teachers who have completed the minimum eligibility period for promotion under CAS will be entitled to the benefit of CAS promotion from the later date of eligibility.
- vi) Teachers who are disqualified in the first assessment will be re-evaluated for one year only and will be paid one year after the date of disqualification of CAS promotion.

For more information, issue No. 6.1, 6.2, 6.3, 7.0, 7.1, 7.2, 7.3, 7.4 in Government Resolution dated 08-03-2019 should be read.



The said resolution mentions the State Government has decided to implement and to revise pay scales and terms and conditions of services of teachers and other equivalent posts in Universities and Colleges.

However, as no Statutes are made in this behalf, as per the decision of the University Authority and the powers vested to me under section 12 (8) of the Maharashtra Public Universities Act, 2016, I Professor Dr. Devanand Baburao Shinde. Vice-Chancellor of the Shivaji University, Kolhapur for the time being regulate matter by issuing directions mentioned below:

- 1. Government of Maharashtra, Higher and Technical Education Department resolution bearing No. Misc- 2018/ C.R.56 / 18 /UNI-1, dated 08th March, 2019 is enclosed herewith as a part of this Order and shall be applicable to the teachers in the University, affiliated colleges and recognized institutions with effect from 1st January,
- 2. This Order shall remain in force till the Statutes in this regard come into force as per the provisions under section 71 (20) of the Maharashtra Public Universities Act, 2016.
- 3. It is clarified that the existing Statutes so far they are not inconsistent with the enclosed Government Resolution, shall remain in force.

University Grants Commission vide its letter dated 31st January, 2018 mentioned that the Government of India MHRD, Department of Higher Education, New Delhi vide its letter dated 2nd November 2017 regarding revision of 7th Pay of teachers and equivalent orders in universities and colleges following the revision of pay scales of Central Government employees on the recommendations of the 7th Central Pay Commission and to say that the State Government may take action to adopt the Government of India's scheme for State Universities and colleges.

The revision of Pay Scales of teachers and equivalent academic staff shall be subject to provisions of the scheme of revision of Pay scales as contained in letter dated 2nd November, 2017 and regulation issued by UGC dated 18th July, 2018 and amendments thereof from time to time in this behalf.

Constitution of Selection Committees and Guidelines on Selection Procedure

Selection Committee Composition

1. Assistant Professor in the University:

- a) The Selection Committee for the post of Assistant Professor in the University shall consist of the following persons:
 - i. The Vice-Chancellor or the Pro-Vice-Chancellor upon the directions of the Vice-Chancellor shall be the Chairperson of the Committee;
 - ii. One person, not below the rank of professor, nominated by the Chancellor:
 - šii. The Dean of the Faculty concerned as a member secretary;
 - The Head of the university department or a head of the concerned School of multidisciplinary institution, nominated by the Vice-Chancellor;
 - Not less than three experts nominated by the Management Council out of a panel of not less than six names of experts not connected with the university recommended by the Academic Council, who have special knowledge of the subject for which the teacher is to be selected:
 - vi. One person not below the rank of Professor or Principal belonging to Scheduled Castes or Scheduled Tribes or De-notified Tribes (Vimukta Jatis) or Nomadic Tribes or other Backward Classes, nominated by the Chancellor;
 - vii. One principal who is a member of management council to be nominated by the Management Council;
 - Director, Higher Education or his nominee not below the rank of viii. Joint Director. Provided that, a head referred to in clause (iv) above, who is an Associate Professor shall be a member of the Selection Committee
- for the selection to the post of Assistant Professor. b) Four members, including two outside subject experts, shall constitute the quorum.

II. Associate Professor in the University

a) The Selection Committee for the post of Associate Professor in the University shall consist of the following persons:

College Institution. The selection committee shall be as per the guidelines prescribed by the State Government in the Official Gazette.

VI. College Principal

There shall be a selection committee for recommending names of the suitable candidates for appointment for the post of college Principal. The selection committee shall be as per the guidelines prescribed by the State Government in the Official Gazette.

- a) The term of appointment of the Principal, shall be five years with eligibility for reappointment for one more term. If the Management intends to reappoint the existing Principal, the Management shall initiate the process of external peer review at least six months before.
- b) The external peer review committee prescribed in clause (c) above, shall consist of the following members, namely:
 - i. Nominee of the Vice-Chancellor, Chairperson;
 - ii. Nominee of the Chairperson of the Management of the College/Institution;

The nominees shall be from the Principals of the Colleges with Excellence Colleges with Potential for Excellence/Autonomous Colleges/ NAAC A or A+ accredited Colleges/Director or Head of the University Department.

- c) The report of the external peer review committee shall be the main basis for re-appointment of the Principal.
- d) If the external peer review committee recommends for re-appointment of the existing Principal, the Management shall re-appoint such existing Principal for one more term.
- Selection Committees for the posts of Directors of Sports and Physical Education, VII. Deputy Directors, Assistant Directors of Physical Education and Sports, Director, Knowledge Resource Center, Deputy Librarians and Assistant Librarians shall be the same as that of Professor, Associate Professor and Assistant Professor, respectively, except that in Library and Physical Education and Sports or Sports Administration, respectively, practicing Librarian/Director Physical Education and Sports, as the case may be, shall be associated with the Selection Committee as one of the subject experts.

- For University Assistant Director, Physical Education and Sports:
 - i. The Vice-Chancellor shall be the Chairperson of the Committee:
 - ii. The Dean of the Faculty concerned:
 - iii. The University Director, Physical Education and Sports;
 - One expert in Physical Education and Sports Administration from University System nominated by the Vice-Chancellor from the University panel of expense and
 - Director Higher Education or his her nominee not below the rank of Joint
- F. For College Director, Physical Education and Sports:
 - The Principal shall be the Chairperson of the Committee; i.
 - ii. The University Director, Physical Education and Sports;
 - Two experts in Physical Education and Sports Administration from University System nominated by the Vice-Chancellor from the University panel of experts; and
 - Joint Director Higher Education or his her nominee not below the rank of Associate Professor.

Note: The quorum for these committees in all categories shall be three which will include the Government nominee, one subject expert university nominee.

- 6.2. The Screening-cum-Evaluation Committee on verification evaluation of grades secured by the candidate through the Assessment Criteria and Methodology Proforma designed by the respective university based on these Rules and as per the minimum requirement specified:
 - In Appendix II, Table 1 for each of the cadre of Assistant Professor;
 - In Appendix II, Table 4 for each of the cadre of Librarian; and
 - In Appendix II, Table 5 for each of the cadre of Physical Education and e)

shall recommend to the Syndicate Executive Council Board of Management of the University College about the suitability for the promotion of the candidate(s) under CAS for implementation.

The selection process shall be completed on the day last day of the selection committee 6.3. meeting, wherein the minutes are recorded and recommendation made on the basis of the performance of the interview are duly signed by all members of the selection committee,

6.4. For all Selection Committees specified in these Rules, Head of Department / Teacher In charge should be either in the same or higher rank/ position than the rank/position for which the interview is to be held.

7.0. Selection Procedure:

- The overall selection procedure shall incorporate transparent, objective and credible methodology of analysis of the merits and credentials of the applicants based on the weightage given to the performance of the candidate in different relevant parameters and his/her performance on a grading system proforma, based on Appendix II, Tables 1, 2, 3A, 3B, 4, and 5.
 - In order to make the system more credible, universities may assess the ability for teaching and / or research aptitude through a seminar or lecture in a classroom situation or discussion on the capacity to use the latest technology in teaching and research at the interview stage. These procedures can be followed for both the direct recruitment and the CAS promotions, wherever selection committees are prescribed.
- The universities shall adopt these Rules for selection committees and selection procedure 11. through their respective statutory bodies incorporating Appendix II, Table 1, 2, 3A, 3B, 4, and 5 at the institutional level for University Departments and their Constituent colleges /Conducted colleges/ affiliated colleges (Government/Government- aided/Autonomous/ Private Colleges) to be followed transparently in all the selection processes. The universities may devise their own self-assessment-cum-performance appraisal forms for teachers in strict adherence to the Appendix II, Table 1, 2, 3A, 3B, 4, and 5.
- 111. In all the Selection Committees of direct recruitment of teachers and other academic staff in universities and colleges provided herein, an academician belonging to the Scheduled Caste/Scheduled Tribe/OBC/Minority/Women/Differently-abled categories, if any of candidates belonging to these categories is the applicant and if any of the members of the selection committee does not belong to that category, shall be nominated by the Vice-Chancellor of the University, and in case of a College, Vice-Chancellor of the University to which the college is affiliated to. The academician, so nominated for this purpose, shall be one level above the cadre level of the applicant, and such nominee shall ensure that the norms of the State Government, in relation to the categories mentioned above, are strictly followed during the selection process.
- The process of selection of a Professor shall involve the inviting of the application IV. developed by the respective university, based on the Assessment Criteria and Methodology

- b) Table 4 of Appendix II is applicable to Assistant Librarians/ College Librarians and Deputy Librarians for promotion under Career Advancement Scheme; and
- c) Table 5 of Appendix II is applicable to Assistant Directors/ College Director of Physical Education sports and Deputy Directors/Directors of Physical Education and Sports for promotions under Career Advancement Scheme.
- The constitution of the Selection Committees and Selection Procedure as well as the Assessment Criteria and Methodology for the above cadres, either through direct recruitment or through Career Advancement Scheme, shall be in accordance with these Rules. The constitution of the Selection Committee for Associate Professors and Professors in Colleges under Career Advancement Scheme shall be as specified in University Grants Commission Regulations dated 18.7.2018.
- The criteria for promotions under Career Advancement Scheme laid down under these Rules shall be effective from the date of notification of these Rules. However, to avoid hardship to those faculty members who have already qualified or are likely to qualify shortly under the existing Rules, a choice may be given to them, for being considered for promotions under the existing Rules. This option can be exercised only within three years from the date of notification of these Rules.
 - ı. A teacher who wishes to be considered for promotion under the CAS may submit in writing to the university/college, within three months in advance of the due date, that he/she fulfils all the requirements under the CAS and submit to the university/college the Assessment Criteria and Methodology Proforma as evolved by the university concerned supported by all credentials as per the Assessment Criteria and Methodology guidelines set out in these Regulations. In order to avoid any delay in holding the Selection Committee meetings for various positions under the CAS, the University/College may initiate the process of screening/selection, and complete the process within six months from the receipt of application. Further, in order to avoid any hardship, the candidates who fulfill all other criteria mentioned in these Rules, as on and till the date on which these Rules are notified, can be considered for promotion from the date, on or after the date, on which they fulfill these eligibility conditions.
 - The Selection Committee specifications as contained in Clauses 6.1 to 6.4 shall be 11. applicable to all direct recruitments of faculty positions and equivalent cadres and Career Advancement promotions from Assistant Professor to Associate Professor, from Associate Professor to Professor, Professor to Senior Professor (in University) and for equivalent cadres.
 - 111. The CAS promotion from a lower stage to a higher stage of Assistant Professor shall be conducted through a "Screening-cum-Evaluation Committee", following the criteria laid

on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 and its amendments with relaxation in the requirements of Academic Performance Indicators (API) based Performance Based Appraisal System (PBAS) up to the date of notification of these Rules.

- c) The relaxation in the requirements of Academic Performance Indicators (API) based Performance Based Appraisal System (PBAS) up to the date of notification of these Rules, for the promotion from one Academic Level/Grade Pay to another under CAS as provided in UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 and its amendments, is defined as under:
 - i) Exemption from scoring under Category I, as defined in Appendix III of said above mentioned UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 and its amendments including University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education) (4th Amendment), Regulations, 2016, for faculty and other equivalent cadre positions.
 - ii) Scoring in Category II and Category III for faculty and other equivalent cadre positions shall be as provided for in the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and Measures for the Maintenance of Standards in Higher Education 2010 with the following combined minimum API score requirement for Category II and Category III taken together, as mentioned in Appendix III, Table-A to Table-F.

Note: There shall be no minimum API score requirement for Category II and Category III individually.

- VIII. The requirement for Orientation course and Refresher course for promotions due under the CAS shall not be mandatory up to 31st December, 2018.
- 7.4. STAGES OF PROMOTION UNDER THE CAREER ADVANCEMENT SCHEME OF INCUMBENT AND NEWLY-APPOINTED ASSISTANT PROFESSORS/ASSOCIATE PROFESSORS/PROFESSORS

- A. The entry-level Assistant Professors (Level 10) shall be eligible for promotion under the Career Advancement Scheme (CAS) through two successive levels (Level 11 and Level 12), provided they are assessed to fulfill the eligibility and performance criteria as laid down in Clause 7.3 of this resolution
- Career Advancement Scheme (CAS) for College teachers
 - Assistant Professor (Academic Level 10) to Assistant Professor (Senior Scale/ 1. Academic Level 11)

Eligibility:

1) Assistant Professors who have completed four years of service and having a Ph.D. degree or five years of service and having a M.Phil PG Degree in Professional Courses, such as L.L.M. M.Tech., M.V.Sc., M.D., or six years of service for those without Ph.D. M.Phil. PG degree in Professional Courses.

2)

- i. Attended one Orientation Course of 21 days' duration on teaching methodology; and
- Any one of the following: Completed one Refresher | Research Methodology Course

OR

Any two of the following:

Workshop, Syllabus Up-gradation Workshop, Training Teaching-Learning-Evaluation, Technology Programmes and Faculty Development Programmes of at least one week (5 days) duration.

OR

Completed one MOOCs course (with e-certification) or development of e-contents in four-quadrant MOOCs course during the assessment period.

CAS Promotion Criteria:

A teacher shall be promoted if;

i. He'she gets 'satisfactory' or 'good' grade in the annual performance assessment reports of at least three/four five of the last four/five/six years of the assessment period as the case may be, as specified in Appendix II, Table 1, and;

3) Any one of the following during the last three years: completed one course / programme from amongst the categories of Refresher Courses/ Methodology Workshop/Syllabus Up-gradation Workshop/ Teaching- Learning-Evaluation Technology Programme/ Faculty Development Programme of at least two weeks (ten days) duration (or completed two courses of at least one week (five days) duration in lieu of every single course/programme of at least two weeks (ten days) duration); or completed one MOOCs course (with e-certification); or contribution towards development of e-contents in 4-quadrant(at least one quadrant) minimum of 10 modules of a course/contribution towards development of at least 10 modules of MOOCs course/contribution towards conduct of a MOOCs course during the period of assessment.

CAS Promotion Criteria:

A teacher may be promoted if;

- i. He/she gets 'satisfactory' or 'good' grade in the annual performance assessment reports of at least two of the last three years of the assessment period, as prescribed in Appendix II, Table 1, and;
- ii. The promotion to the post of Associate Professor is recommended by the selection committee in accordance with these Rules.

Associate Professor (Academic Level 13A) to Professor (Academic Level 14)

- 1) Associate Professors who have completed three years of service in Academic Level 13A.
- 2) A Ph.D. degree in subject concerned/allied/relevant discipline.
- 3) A minimum of 10 research publications in peer-reviewed or UGC-listed journals out of which three research papers shall be published during the assessment period.
- 4) A minimum of 110 Research Score as per Appendix II, Table 2

CAS Promotion Criteria:

A teacher shall be promoted if;

- i) The teacher gets 'satisfactory' or 'good' grade in the annual performance assessment reports of at least two of the last three years of the assessment period, as per Appendix II, Table I and at least 110 research score as per Appendix II, Table 2.
- ii) The promotion to the post of Professor is recommended by selection committee constituted in accordance with these Rules.
